OLD BUSINESS: VOTING ITEMS

(VOTE)

Agenda Item 2024-04-06 004 Agenda: Submit an agenda item for consideration at the 75th General Service Conference. Revise the Reserve Fund to insist that the General Service Board not allow the Fellowship's financial obligations to go unmet because of an unwillingness to draw from the reserve. Background:

In recent years, both affiliate corporations, AAWS and The Grapevine, have struggled financially to meet their financial obligations. Some of the obligations not met included several months of office rent and other vendors including printers and warehouses. The General Service Board financial reporting indicated bills were several months past due and some incurred late fees/interest. Our 7th Tradition reminds us to be self-supporting. Not paying our creditors because the funds available are in a different account is not in keeping with the spirit of the Traditions nor the principles we practice in our personal lives and home groups.

Agenda Item 2024-04-06 005 Agenda: Submit an agenda item for consideration at the 75th General Service Conference. Provide all Conference Members at least a quarterly update on projects underway at the General Service Office that includes the project timeline and budget status.

Background:

The General Service Office staff works hard throughout the year to serve the fellowship. Many projects are ongoing that are worked on simultaneously. A visually appealing spreadsheet that is regularly updated providing the timeline and budget status of these projects would help inform the Conference when considering future agenda items that have resource implications. This reporting would also give increased transparency to the fellowship on the variety of projects underway.

Agenda Item 2024-01-06 003 Report & Charter: The Area 41 Reunion Chair will be responsible for securing volunteers to fill the Area 41 Reunion Committee, rather than the committee being filled by a Reunion Host Committee led by volunteer district(s) selected from bids. The Area 41 Area Reunion committee will host an annual Area 41 Reunion in a manner keeping with our traditional event as outlined in Section IX.A of the Area 41 Handbook.

The committee will include two elected positions: the Reunion Chair and the Reunion Alt-Chair. The Reunion Chair will be responsible for securing volunteers to fill the committee so that it may host the annual Area 41 Reunion. The Reunion Chair will serve a one-year term to begin during the first area 41 business meeting following the area 41 reunion. They will be funded to attend area 41 business meetings for their term, one night and mileage at the Area 41 rate, and to attend the Area 41 Reunion, two nights and mileage at the area 41 rate. When the Reunion Chair position is vacant, if a Reunion Alt-Chair is available and willing, they will become the Reunion Chair. If the Reunion Alt-Chair position is vacant, then the Area 41 Chair will select a panel of candidates from which area 41 will elect the Reunion Chair, via third legacy procedures. The Reunion Alt-Chair will be funded to attend two Area 41 business meetings, one night and mileage at the Area 41 rate, and to attend one Area 41 Reunion, two nights and mileage at the Area 41 rate. During an Area 41 Business Meeting sufficiently in advance of the Reunion to allow the Alt-Chair to attend two Area 41 business meetings, the Area 41 Chair will select a panel of candidates from which area 41 will elect the Reunion Alt-Chair, via third legacy procedures.

Funding for the Reunion (seed money) will be dispersed at the current amount and schedule. Facility costs will be added into the annual budget (not paid for from the seed money). The annual budget for the following positions to be adjusted to cover their attendance at the Reunion: Archives Chair, Literature Chair and Grapevine Chair for two nights and mileage at the Area 41 rate. The Delegates attendance will continue to be funded through the Delegates budget. Any funds gathered at the Reunion (donations or registration fees) will be turned over to the Area 41 Treasurer. EXPERIMENTAL: This is for a four-year trial period. It will sunset and the Reunion structure revert to the district-based organization if not adopted following the fourth experimental event, or earlier.

Background: ASSEMBLED BY THE AREA 41 REUNION AD-HOC COMMITTEE:

Pluses of the Reunion

- -Opportunity for members to hear Delegate's Report of the GSC
- -Lots of fellowship
- -More opportunities for service work

Challenges of the Reunion

- -Trend toward low attendance in recent years
- -Difficulty being self-supporting some years
- -Difficulty finding different districts willing to host the event

Other Points Considered:

There may be some good information learned from the area Ad-hoc Function Committee. We don't currently have the benefit of knowing what any of that information may be.

Area 41 is currently locked in to having the Reunion through 2024 only. A vote is scheduled October 2023 to set dates and facilities for 2025 and 2026 Reunion.

The Delegate's Report is given at the Reunion and also given approximately 1 month later at the Area business meeting. Sometimes it has been the same or a very similar report, but it doesn't have to be. It's unknown what would be the Area financial ramifications of not having a reunion (the cost that could be saved not having a Reunion versus the change in costs for the other 4 annual business meetings without having a Reunion). We found that there were just too many variable such as dates, locations and different hotel policies to determine if eliminating the Reunion and meeting 4 times per year rather than 5 times would be financially beneficial to Area 41. We'd need to solicit actual bids for 4 meetings vs 5 meetings to know for certain what impact this would have on the Area finances.

We discussed at length the possibility of Area 41 establishing a Reunion Committee rather than having districts host it.

We discussed having a one day event rather than having the Reunion last the entire weekend.

There was talk of somehow attaching the Reunion to the 4-Corners Workshop.

There was mention and discussion of the possibility of changing the Reunion date(s).

The Reunion is held when it is aligned with an Alanon Business meeting. Alanon's Service Conference is held in the spring just as our GSC is. Alanons in Nebraska meet 4 times per year (3 business meetings and 1 reunion). They meet in conjunction with Area 41 meetings at all except our January meetings.

We think we may need to advertise more.

We think providing more seed money could benefit some Reunion committees. Also, not being as adamant that the seed money be returned could help some committees.

We could use officers' and/or committee chairs' budgets (i.e. Delegate, Literature, Grapevine, Archives) rather than Reunion committee budget to pay for hotel sleeping rooms or meeting rooms.

Host districts could communicate more with previous host committees to get more information and ideas concerning reunion "best practices".

We could reconfigure the agenda of the Reunion. We could have workshops at the Reunion.

We were able to get some past Reunion attendance records and finance records. The results were as follows

We have financial information from 14 of the past 17 reunions. That shows an overall profit for the Reunion of \$5360.67.

We have attendance records from 15 of the past 17 reunions. We consider the low attendance from the 2020 & 2021 as outliers rather than part of a trend since they were held during COVID. But there has been a

downward trend from 2007 til now even though the number of attendees does not seem to correlate with the annual financial profits vs losses.

We feel that two of the major problems the Area is experiencing with the reunion are as follows:

- 1. We discussed the fact that there doesn't always seem to be a lot of interest shown from individual districts who would like to volunteer to host the reunion.
- 2. We think more continuity is needed from year to year with each new reunion committee. Non-Emergency Floor Action

<u>2022-04-02 004 Agenda Item Report & Charter: Evaluate alternative methods for recording Area 41 functions.</u>

Background: The originator of this item made a floor action per the Area 41 Handbook to have it brought back for a vote on the floor at this assembly.

Currently, all Area 41 Assemblies are taped to preserve a historical record of Area 41 meetings. The Area 41 Taper ensures all Area Assemblies and other Area functions as directed by the Chairperson and Secretary are taped (Agenda Item 2009-01-17 011). Area 41 owns a laptop and taping equipment for the purpose of taping Area 41 functions. With the advancements in technology, a review of alternative methods should be conducted to ensure Area 41 is preserving its history while using the best method available.

Report and Charter Committee Notes:

The committee recommended having an alternative method of recording. The item was resolved in committee, to take no action per page 38 of the Area 41 Agenda Items Listing. The decision was unanimous. Zoom recording (using the license Area presently owns) coupled with any attending member's generous loan for the day of their laptop.

NEW BUSINESS: ASSIGNED TO COMMITTEE

Agenda Item 2024-07-13 007 Report & Charter: Rescind Agenda Item 2022-10-09 016: Update the scope of the Alternate Delegate to include Nebraska Conference of Young People in Alcoholics Anonymous (NCYPAA) Liaison, which could include attending the annual NCYPAA conference. Budgeting for costs would follow the normal Area 41 procedures in the Finance Guidelines.

Background: The motivations behind the original agenda item were well intended and honorable. However, since Area 41 is an extension of AA groups, we are bound by the Steps, Traditions, and Concepts. Hence, any action we take must not be contrary to them in any way. The long form of Tradition Six concludes with this statement, "While an AA group may cooperate with anyone, such cooperation ought never to go so far as affiliation or endorsement, actual or implied. An AA group can bind itself to no one." A liaison is defined by Oxford Learner's Dictionaries as "a relationship between two organizations... involving the exchange of information or ideas...". NCYPAA is a part of YPAA, which is an organization unto itself; therefore, it is independent of Alcoholics Anonymous. By creating a liaison role, we have an implied affiliation with them and by approving the use of our resources to attend their events an actual endorsement exists.

Agenda Item 2024-07-13 008 Report & Charter (AATRC/Tech&Comm): Explore offering Spanish translation for all Area 41 events including 4-corners workshops and assemblies.

Background: We have a Spanish linguistic district to which we encourage participation. We offer a Spanish newsletter but do not offer any in person translation. Having members from the district translate can be daunting as it's a lot to ask of someone to do that for an entire weekend. If we want to foster participation we should make it easily accessible for everyone.

Agenda Item 2024-07-13 009 Agenda: Consider District 9's request to revise the Area boundary and move the District 9 area to Area 76. If approved, this would require the Area to submit an agenda item to the General Service Conference for consideration.

Background: District 9 has asked area 41 an area 76 to begin discussing what it would look like to change the area boundaries so they would be included as a part of the Wyoming area instead of the Nebraska area. To do this an item must be submitted by both areas to the general service conference for approval.

In January a letter was written to Director Jeffreys at the Nebraska Department of Correctional Services (NDCS). His assistant forwarded the letter to Chrisine Hinzman, the Partnership Program Manager for Volunteer and Religion Services. I emailed Ms. Hinzman in March and she replied saying she would reach out to the facility contacts to see if there are any current needs for AA support or services.

I received an email from the AA General Service Office Corrections Coordinator, Nick S. A person in custody from the Tecumseh State Correctional Facility requested to have AA Literature and an AA meeting brought into the facility. I emailed Ms. Hinzman about this request and let her know we are willing to help carry the message of AA into Tecumseh.

Members of our committee provided information on AA meetings currently in correctional facilities and we are putting together a list to send out for other members who may be willing to volunteer in the facilities near them. The list will continue to be updated as new information is received. I attended the WCRAASC in Minot ND with a group of other alcoholics. What a wonderful trip and a great Conference.

The Corrections Committee opened with the Serenity Prayer and introductions. There were 14 people in attendance. The above information was shared with the group and they provided updates to the list. The DCM for District 5 will help get information about what is currently being done in Tecumseh and how we can do more. The Omaha Intergroup Bridging the Gap (BTG) chair sat in for part of the meeting. He shared about BTG and encouraged us to tell persons in custody of the service it provides. Area 41 April Finance Report

Finance committee opened at 3:58 pm with 13 in attendance. Traditions were read. The current account status was discussed:

Main account: \$30,243.17; Prudent reserve :\$11,797.11;

7 th Tradition Contributions for 1 st Quarter:

93 groups contributed a total of \$8,508.05

Average contribution was \$94.53

47 contributions were less than \$50

The committee discussed additional funding requests received this quarter thus far. Several committee chairs had additional printing costs; totality of request was less than \$100. The Area secretary requested an additional night of funding. Secretary was put in one of the comped rooms for this session, but will receive an additional night of funding based on mileage guidelines in the Area handbook. We discussed known upcoming budget adjustments, including archives rent and the Archivist attending a conference in the 3 rd Quarter. Several new items were discussed and decided. There was an outstanding balance with our newsletter vendor from 2023 Q4. The balance was paid; the chair is working through an audit of the Newsletter sub account to better understand the outstanding balance. The liability insurance we carry lapsed during the rotation transition period. Our Alt Delegate worked her magic and was able to get the same policy for \$100 less. Literature:

The Area 41 Literature Committee meeting opened at 4:00 pm with Rowan F. reading the Traditions. We had seven attendees representing six different Districts (4,6,7, 21,22 & District 15). It was great to have so much participation. The committee reviewed the previous committee report. District 15 is currently leading the the

first "Pamphlet Challenge" of 2024. The district with the most pamphlet purchases before 30 JUN will be awarded \$10.00. The second "Pamphlet Challenge" for 2024 will begin 01JUL and will end 31 DEC. We have plenty of Newcomer, Correction, Service & pamphlet packets available. We also have Spanish Paquete de Recien Llegado available. For quarter one of 2024, the Literature budgeted account (Hotel & Damp: Travel) balance forward was \$288.16. Hotel & amp; travel expenses were \$204.82 leaving an ending balance of \$83.34. The Literature sales account balance forward was \$1241.09. Income was \$2644.81 and expenses were \$3315.07 leaving an ending balance of \$614.07. Subtracting outstanding purchases that haven't cleared the account of \$33.50 and collected sales tax due to the state of Nebraska at \$153.52 gives us a working balance of \$427.05. The Literature Committee discussed and voted to do a "Pamphlet Spotlight" - which means that at each Area 41 Assembly the committee will select a pamphlet for each month of the quarter to highlight. The goal is to get us reading more pamphlets. We have a ton of great literature. This "Pamphlet Spotlight" will hopefully challenge us to read more of it. Report and Charter:

The committee met on 10 March with 6 in attendance on Zoom. The committee was visited by members of the Function ad hoc committee. There was a presentation of the dual intentions of the Function and the Reunion committee, which is now finished. The presentation concerned the Agenda Item 2024-01-06-003 Report and Charter: Area 41 to form a new Area Committee with hosting the area reunions. Their concerns were appriciated. Agenda Item 2024-01-06-003 was then taken up for our consideration. Zach suggested doing a rewrite and making changes to the Item. More information is needed from the Finance committee, to do with added costs of a new committee chair and alt. We then discussed updating the Area Map and a to-be proposed agenda Item on the scope of the Newsletter Chair.

The committee then met on 6 April with 9 in attendance. The Area Secretary had no new business. We then took up the Area Map review. Mike has been doing research on the task. We discussed different issues to do with the map. Mike will continue doing research on the review.

Agenda Item **2024-01-06-003** was taken up again. Mike and Zach presented their draft to the committee. We discussed the importance of creating a good understanding for future assemblies to understand why and how we arrived at the changes. The treasurer remarked there are no great obstacles to funding. As this is an important issue we are putting a call out to all interested members to attend our meeting and provide input. Controversial issues included: adding DCMs to the Reunion committee, the merits of a one year rotation for the chair, the merits of an alt-chair replacing the outgoing chair at the end of the year, the merits of a trial period of 4 years and adding this to the Area Handbook. The Item was unanimously approved to move to a vote. Agenda Items in Committee:

Agenda Item 2022-04-02 #003 Report and Charter: Consider how to incorporate virtual groups that choose to participate in Area 41 into the Area 41 service structure. Agenda Item 2024-01-06 #001 Report and Charter: Clarify the scope of standing committees to resolve agenda items in committee. Agenda Items moving out of committee to vote.

Agenda Item 2024-01-06 #003 Agenda Item 2024-01-06 003 Report and Charter: The Area 41 Reunion Chair will be responsible for securing volunteers to fill the Area 41 Reunion Committee, rather than the committee being filled by a Reunion Host Committee led by volunteer district(s) selected from bids. The Area 41 Area Reunion committee will host an annual Area 41 Reunion in a manner keeping with our traditional event as outlined in Section IX.A of the Area 41 Handbook. The committee will include two elected positions: the Reunion Chair and the Reunion Alt-Chair. The Reunion Chair will be responsible

for securing volunteers to fill the committee so that it may host the annual Area 41 Reunion.

The Reunion Chair will serve a one-year term to begin during the first area 41 business meeting following the area 41 reunion. They will be funded to attend area 41 business meetings for their term, one night and mileage at the Area 41 rate, and to attend the Area 41 Reunion, two nights and mileage at the area 41 rate. When the Reunion Chair position is vacant, if a Reunion Alt-Chair is available and willing, they will become the Reunion Chair. If the Reunion Alt-Chair position is vacant, then the Area 41 Chair will select a panel of candidates from which area 41 will elect the Reunion Chair, via third legacy procedures. The Reunion Alt-Chair will be funded to attend two Area 41 business meetings, one night and mileage at the Area 41 rate, and to attend one Area 41 Reunion, two nights and mileage at the Area 41 rate. During an Area 41 Business Meeting sufficiently in advance of the Reunion to allow the Alt-Chair to attend two Area 41 business meetings, the Area 41 Chair will select a panel of candidates from which area 41 will elect the Reunion Alt-Chair, via third legacy procedures. Funding for the Reunion (seed money) will be dispersed at the current amount and schedule. Facility costs will be added into the annual budget (not paid for from the seed money). The annual budget for the following positions to be adjusted to cover their attendance at the Reunion: Archives Chair, Literature Chair and Grapevine Chair for two nights and mileage at the Area 41 rate. The Delegates attendance will continue to be funded through the Delegates budget. Any funds gathered at the Reunion (donations or registration fees) will be turned over to the Area 41 Treasurer.

EXPERIMENTAL: This is for a four-year trial period. It will sunset and the Reunion structure revert to the district-based organization if not adopted following the fourth experimental event, or earlier.

Background: ASSEMBLED BY THE AREA 41 REUNION AD-HOC COMMITTEE:

Pluses of the Reunion

- -Opportunity for members to hear Delegate's Report of the GSC
- -Lots of fellowship
- -More opportunities for service work

Challenges of the Reunion

- -Trend toward low attendance in recent years
- -Difficulty being self-supporting some years
- -Difficulty finding different districts willing to host the event

Other Points Considered:

There may be some good information learned from the area Ad-hoc Function Committee. We don't currently have the benefit of knowing what any of that information may be. Area 41 is currently locked in to having the Reunion through 2024 only. A vote is scheduled October 2023 to set dates and facility for 2025 and 2026 Reunion. The Delegate's Report is given at the Reunion and also given approximately 1 month later at the Area business meeting. Sometimes it has been the same or a very similar report, but it doesn't have to be. It's unknown what would be the Area financial ramifications of not having a reunion (the cost that could be saved not having a Reunion versus the change in costs for the other 4 annual business meetings without having a Reunion). We found that there were just too many variable such as dates, locations and different hotel policies to determine if eliminating the Reunion and meeting 4 times per year rather than 5 times would be financially beneficial to Area 41. We'd need to solicit actual bids for 4 meetings vs 5 meetings to know for certain what impact this would have on the Area finances.

We discussed at length the possibility of Area 41 establishing a Reunion Committee rather than having districts host it. We discussed having a one day event rather than having the Reunion last the entire weekend. There was talk of somehow attaching the Reunion to the 4-Corners Workshop. There was mention and discussion of the possibility of changing the Reunion date(s). The Reunion is held when it is aligned with an Alanon Business meeting. Alanon's Service Conference is held in the spring just as our GSC is. Alanons in Nebraska meet 4 times per year (3 business meetings and 1 reunion). They meet in conjunction with Area 41 meetings at all except our January meetings. We think we may need to advertise more. We think providing more seed money could benefit some Reunion committees. Also, not being as adamant that the seed money be returned could help some committees. We could use officers' and/or committee chairs' budgets (i.e. Delegate, Literature, Grapevine, Archives) rather than Reunion committee budget to pay for hotel sleeping rooms or meeting rooms. Host districts could communicate more with previous host committees to get more information and ideas concerning reunion "best practices". We could reconfigure the agenda of the Reunion. We could have workshops at the Reunion. We were able to get some past Reunion attendance records and finance records. The results were as follows: We have financial information from 14 of the past 17 reunions. That shows an

overall profit for the Reunion of \$5360.67. We have attendance records from 15 of the past 17 reunions. We consider the low attendance from the 2020 & 2021 as outliers rather than part of a trend since they were held during COVID. But there has been a downward trend from 2007 til now even though the number of attendees does not seem to correlate with the annual financial profits vs losses. We feel that two of the major problems the Area is experiencing with the reunion are as follows:

- 1. We discussed the fact that there doesn't always seem to be a lot of interest shown from individual districts who would like to volunteer to host the reunion.
- 2. We think more continuity is needed from year to year with each new reunion committee.

Technology and Communications:

Good morning, Area 41,

Between area assemblies, the Technology & Communications Committee met twice online.

At the January assembly, the committee prioritized Agenda Item 2022-04-02 007: Review website technologies and consider an updated platform (i.e. WordPress) to manage and maintain the Area 41 website. All efforts have centered on this item, and our other agenda items in committee are tabled at this time.

On February 3, we had eight members in attendance. We confirmed how we would divide the list of Area Websites in the US between ourselves, and the questions/prompts by which to record observations (for consistency in reporting). An online form to collect these observations was set up.

We also discussed the upcoming Website Workshop/Sharing Session to occur at the April assembly. The committee's consensus was that our own website research would guide our presentation content, and we did not find it necessary to seek additional feedback from the area in advance of the workshop.

On March 9, with eight members in attendance, we first took a committee conscience on current work that should be done with our existing website, and what should be paused. The consensus was to pause further development of new items, but to fix anything clearly not working. Paused items include: Spanish translation of existing web pages — though we agree this needs to be a priority; TSML Meeting Locator development regarding UI vs. Wordpress plugin, and appearance of meeting list pages; reorganization of pages for 'mobile first' layout; newsletter subscription service debugging. The item requiring immediate work is that some contact forms are not working. Our webmaster was to troubleshoot—and the committee encouraged our Webmaster to have the first opportunity at troubleshooting and taking corrective measures, before backup help.

We then again focused on the upcoming Website Workshop/Sharing Session, reviewing our observations/research on other US websites and how to use them in our presentation. It was clear that we couldn't have a productive conversation regarding website builder services or plug-ins until we have a clear understanding of what the area wants for area41.org content and purpose. The committee concluded that the workshop would focus on intent and content only, and not software/tools or budget, with proposed questions utilizing a "would you rather?" type of format; and to identify hot items that if the area didn't tell us, it would be hard to choose ourselves.

On April 6, at assembly, the committee commenced at 4:04 PM with the Serenity Prayer. We had a total of 10 members in attendance, with one new attendee to this rotation. We utilized our hour in committee to finalize our presentation for the following hour's Website Workshop/Sharing Session, to ensure we could get the most-needed feedback during our limited time with you all.

We transitioned into the next room for the workshop, which was swift and productive, and very well attended.

- The apparent area consensus includes the following:
 - o for the area website to include newcomer/recovery information (or links) and (AA conference approved) information for professionals, in addition to service information;
 - for the home page to include a banner image followed by 'button' type navigation.
- The committee has already deemed the following content as important and highly likely, and did not seek feedback:
 - embedded meeting list with maps;
 - links to Meeting Guide app downloads;
 - events calendar with fliers, alternate text, and maps;
 - Spanish translation;
 - links to AA.org and Grapevine/La Viña.
- The apparent area consensus regarding site content includes the following:
 - to keep a password wall, but revisit which items truly need to be behind it, with hopes that more service material would be easier for anyone to find;
 - keep events calendar open to local events throughout the state, such as group anniversaries, workshops, holiday events, and picnics, but may need to revisit the parameters for the events we post or add a 'disclaimer' for events that are not exclusively AA;
 - o include site pages for districts, committees, and service positions.
- Additional suggestions included:
 - o increase the time limitation for automatic logout from 15 minutes;
 - o is there a way to have some type of 'interactive directory' functionality, to help provide officers with current contact lists for districts and groups;
 - to be mindful to limit the number of buttons or menus, if additional ideas are implemented;
 - to include links to Grapevine/La Viña apps in addition to their websites.

Thank you for your participation yesterday. The committee was grateful for the feedback we received. Any additional feedback can be sent to sarahr.in.recovery@gmail.com or by text to 402.601.1327.

The committee will continue to meet monthly online, in non-assembly months. Our next meeting will be on Saturday, May 11, at 2 PM central time (with a 90-minute time limit), and we welcome additional participants. Our first priority will be to finalize our recommendation for agenda item **2022-04-02 007** regarding website technology.

Our other agenda items in committee remain tabled, and are as follows:

I should probably have reached out to someone regarding this, at least to give someone a reminder, but the weekend got away from me as a result of personal chaos and health issues in my life. I took the commitment of chairing the zoom portion of my local Saturday meeting. Thoughts of taking care of that completely blotted out my memory that Area 41 was meeting this weekend as well. I believe, if plans had been made to have a zoom meeting as we discussed during the last assembly, I would have received notice with log in information and would have been reminded. I would always put my Area 41 commitment ahead of other commitments but I simply forgot and the Area meeting crept up on me rapidly. Keeping track of what day of the week it is has been a challenge of late. I will do my best to not let this happen again. Looking back, I should have asked for more help. My intentions were to get the newsletter out as quickly as possible, but mistakes were made along the way. I have a new plan of attack for this quarter in regards to the newsletter, it should be sent out within 6 weeks of today with less mistakes and should be cheaper.

On January 21st I received everything I needed to compile the newsletter. For the next few days, I was talking with Erin on getting everything together. On January 25th, I finished the English and Spanish copies of the newsletters. I did not struggle with the process. The main reason it took so long was because I was waiting for Amazon to spend me a computer mouse, as I did not want to copy and paste without one.

What I did not know at this time, was that I was supposed to send the newsletter to all of the officers for review. But this quarter will be different. This quarter, I will send the newsletter to the secretary, and she will distribute the newsletter to the officers for review. Next, I got in touch with the recommended printing company, and sent the copies over. I requested 400 English copies and 20 Spanish copies.

On January 28th I was informed of our emergency voting item, and I was asked to contact the printing company to put the order on hold.
